If your group is interested in continuing its league, please submit a completed application and roster form. They must be received by the department by Friday, February 14, 2025. **LATE APPLICATIONS WILL NOT BE CONSIDERED!**

Management will review all applications and rosters using existing policy. All applicants will be notified no later than March 14. Approved applicants will be required to sign an agreement and pay a **booking fee per golfer**. This fee covers the privilege of having a reserved tee time. Leagues will have their approved tee times blocked off in the computerized tee time system. Please consider this policy carefully when selecting a starting time for your league. Please be sure to review the League Rules & Regulations (attached) with your entire league. To ensure the efficiency and safety of our course we will be strictly enforcing the items listed and holding all leagues accountable. All '25 Agreements must be accompanied with a roster which tentatively includes the first and last names of all league members, including substitutes for the upcoming '25 season. All leagues will be required to submit an accurate league roster, subs included, by April 25, 2025. All league play will be monitored by golf course personnel. Computerized league rosters are welcomed. Any additional league information including league schedules is appreciated and can be e-mailed to deerwoodgc@gmail.com

LEAGUE PLAY

Leagues will be given priority to tee off ahead of public golfers if they are on the tee at their scheduled time. Organizations interested in league play must file an application at the Department of Youth, Recreation & Parks prior to February 14, 2025.

Priority system will be used to select the leagues authorized to play each year. Applicants will receive notification not later than March 14, 2025.

The number of leagues authorized will be determined annually. Leagues will be obligated to conform to all rules and regulations of Deerwood Golf Course. Abuse of these rules and regulations will be grounds for exclusion for further play.

Priorities for Reviewing Golf League and Tournament Applications (New Leagues Only).

Permission granted for 1 year only, listed in order of priority:

- a. Churches, clubs, organizations or businesses located in North Tonawanda and composed of strictly North Tonawanda residents.
- b. Churches, clubs, organizations or businesses located in North Tonawanda and composed of both residents and non-resident members.
- c. Clubs, churches, organizations or businesses located in the City of Tonawanda and composed of North Tonawanda residents and non-residents.
- d. Clubs, churches, organizations or businesses located in Tonawanda and composed of strictly Tonawanda residents and non-residents.
- e. Clubs, churches, organizations and businesses not located in the Twin Cities, but having a legitimate organized golfing group, who previously have conducted a league.

All golf leagues in 2025 will be allowed 20 weeks of reserved time for their league season with additional weeks available in case of weather cancellations. The available dates for each day of the week are listed below. Deerwood Golf Course will enforce league reservations only on the listed dates. No rain dates are available. All dates before and after those listed below will be subject to a computerized reservation system.

All A.M. & P.M. Leagues

Thursdays: May 1 to Sept. 18
Friday: May 2 to Sept. 19

NOTE: League starting dates may be moved back 1 week if weather/course conditions dictate

Golf League Rules & Regulations

1. All golfers must have a valid greens fee ticket and set of clubs to be permitted on the golf course.
2. Golfers will play the designated course as indicated by the starters at check-in.
3. Carts will be available according to your tee time.
4. Carts are to remain 30 feet away from greens and approaches.
5. Carts are not permitted in the parking lot.
6. Upon finishing your round, please return the cart to the cart barn immediately so that we can get the next league groups out with carts on time. (NO LOITERING in groups around greens or on pathways).
7. All golfers are required to maintain a reasonable pace of play. Normal pace of play is 2 hours and 15 minutes per 9 holes. Please utilize the forward tees if your abilities do not allow you or your group to keep pace with the group in front of you.
8. Please exercise proper golf etiquette and respect other golfers, the golf course and the golf course staff. Failure to comply with these rules could lead to removal from the course and possible suspension from the course.
9. No outside food or beverage allowed on the premises. If league golfers are going to remain onsite after their round of golf all food & drink should be purchased from our concessionaire.
10. Failure of league golfers to abide by these and any other posted rules and regulations will result in the potential league forfeiture of tee-times with no refund. League president/contact is responsible for ensuring compliance and working with course supervisors as needed.
