## **2025 Application for Tournament Play**

### **Instructions**

1. Please type or print. Application form should be completely filled out before filing.
2. Please read the golf course policies regarding tournament play before completing this application form (see enclosure).
3. Any special requests should be made on the reverse side of the application form.
4. As soon as your application is received at the North Tonawanda Recreation Office, you will be penciled in on your requested date. Upon receipt of your signed Tournament Agreement and booking deposit, your tournament date becomes permanent.
5. Applications can either be filed in person or mailed to the North Tonawanda Recreation Office, 500 Wheatfield Street, North Tonawanda, NY 14120, Monday through Friday between 8:30 a.m. and 4:30 p.m. or e-mailed to [Deerwoodgc@gmail.com](mailto:Deerwoodgc@gmail.com)
6. Since there are a limited number of available tournament dates, delays in filing an application may result in fewer available dates.

### **Priorities for Reviewing Golf Tournament Applications.**

\*\* Permission granted for 1 year only, listed in order of priority:

1. Churches, clubs, organizations, or businesses located in North Tonawanda and composed strictly of North Tonawanda residents.
2. Churches, clubs, organizations, or businesses located in North Tonawanda and composed of both residents and non-resident members.
3. Clubs, churches, organizations, or businesses located in the City of Tonawanda and composed of North Tonawanda residents and non-residents
4. Clubs, churches, organizations, or businesses located in Tonawanda and composed of strictly Tonawanda residents and non-residents.
5. Clubs, churches, organizations, and businesses not located in the Twin Cities, but having a legitimate organized golfing group, who previously have conducted a league.

## **GOLF TOURNAMENT POLICY**

### **ALL TOURNAMENT APPLICANTS WILL BE REQUIRED TO FOLLOW THESE STIPULATIONS WITHOUT EXCEPTION:**

- 18-hole tournaments will be consecutive foursomes off the #1 tee of the designated 18-hole course or split tee format using the front nine and the 9-hole course for that week. 9-hole tournaments will start off the #1 tee of designated 9-hole course.
- All tournaments must use a four-golfer scramble format (18 holes) unless special permission is granted by the supervisor to play an alternate format.
- Golf Course Supervisor reserves the right to set maximum # of foursomes based on availability of golf carts.
- Tournament Director must contact golf Course director 10 days before tournament with final count so course can open up available tee times to the public. Tournament **MUST** be paid for at this time (10 days prior to the tournament). Failure to do so will result in the tournament being canceled from our tee-sheet and tee times will be made available to the public. Payment to be made by cash/credit or check at the Golf Course ticket office.
- Tournaments that need more carts than we have available are required to secure and pay for their own additional carts through a third-party vendor (contact information will be provided upon request).

**\*DO NOT SUBMIT AN APPLICATION IF YOU CANNOT ADHERE TO THE ABOVE REQUIREMENTS. ALL TOURNAMENT APPLICANTS ARE ALSO RESPONSIBLE FOR ALL OTHER GOLF TOURNAMENT POLICIES INCLUDED IN THIS MAILING.**

Golf Tournament fees (includes one golfer and 1/2 golf cart):  
Weekday and Weekend - 18 Holes - \$40.00  
Weekday and Weekend - 9 Holes - \$26.00

North Tonawanda Recreation ID cards WILL NOT be included in tournament payments. Season golf, golf cart and private cart passes WILL be included in tournament payments.

- **All 18-hole tournaments are required to pay a \$100.00 booking DEPOSIT which is due with the signed agreement and can either be delivered in person or mailed to the North Tonawanda Recreation Office, 500 Wheatfield Street, North Tonawanda, New York 14120. 9-hole tournaments - same as above except the - booking DEPOSIT is \$50.00. This is a DEPOSIT toward tournament greens fees.**
- Rain dates will not be scheduled in advance. Refunds will be given **ONLY** if the course is closed due to weather/course conditions which prohibit the tournament from being held.
- All tournament golfers are required to follow Deerwood Golf Course rules and regulations. Violations could jeopardize tournament reservations in the future.
- No outside food/beverage. Concession arrangements can be made with the Golf Course Restaurant
- Overflow parking is available across the street in the Botanical Gardens parking lot. Since many tournament golfers are at the course most of the day, we would appreciate as many tournament golfers as possible using the overflow parking. Thank you for your cooperation.
